# **Reminders**

### **Recurring Tips for Better Failure Analysis**

- Please submit **on-site photos** *with* the claim form: this is better than after the report is completed
- Send all the evidence parts; we need them! But please note, or mark, the suspected failed component or part(s). If every item has to be described in detail due to insufficient information, extra charges may be incurred.
- Include a few **extra inches of pipe** on either side of a failed plumbing fixture or pipe. This often helps with testing and manufacturer identification.
- Please only use the *current* **DPI Claim Form**.
- Please only use the *current* **DPI address.**
- Please only use the *current* shipping labels.
- Please use DPI's recommended shipper for large items. This logistics company understands the requirements for evidence preservation during transportation.
- Cancellation requests must be received prior to the beginning of a failure analysis. The cancellation fee is \$75.
- Please mark only one (1) box at the top of the DPI Claim Form; choose Level or ID Only [plus Express for rush service].
- Please **respond promptly** to DPI emails for a quicker process time.
- Please do not fold water heater connectors in half. This causes additional internal damage.
- Please use plastic zip-bags to protect documents and claim forms from damp plumbing items or sooty fire-damaged items; they can be impossible to read, which delays process time.

## Corrugated Gas Lines

Pailures of flexible yellow corrugated stainless steel tubing (CSST) used for natural gas and propane lines are becoming more common. A direct or indirect lightning strike may travel to the CSST and result in arcing and perforation of the tube. The electrical arcing may ignite the pressurized gas and result in a fire.

Destructive inspection techniques are required to remove the yellow covering to confirm if arcing is present at any perforation or fracture of CSST.

Please include on-site photos of the tube installation and the bonding wire/clamp points.

#### Environmental Stress Cracking (ESC)

Environmental Stress Cracking (ESC), simply speaking, is a localized failure mechanism of polymers requiring two factors; a chemical acting as a solvent, and stress. ESC requires some chemical contaminant that will weaken the plastic. The chemical is often concentrated in a stress concentration such as a change in part geometry or a scratch. If the component is under stress, a crack or crevice slowly progresses. One well-known situation is cracking due to oils or insecticides on CPVC pipe. An ESC fracture surface in CPVC is typically shiny.

**Name of product:** Utility Vehicles **Hazard:** The oil filter can leak, posing a fire hazard. Pinholes or cracks have been identified in oil filters installed by the engine supplier which were not manufactured to specification.

#### **Recall Details**

Units: About 4,700 Description: This recall involves John Deere Gator™ RSX850i Base, Sport and Trail model recreational utility vehicles manufactured between May 2012 and October 2012. They have side-by-side seating for two people and were available in Realtree® Hardwoods™ HD Camo, olive and black, or traditional green and yellow. RSX850i is located on the hood. The serial number is on the rear frame above the receiver hitch. Utility vehicles with the following serial numbers are included in this recall:
