

As many manufacturers/distributors are simply rebranding foreign-made faucets, faucet failures remain something we encounter on an almost daily basis here at DPI. Faucets are handy household and workplace items we all use every day with little regard to their inner workings and faults.





A leaky faucet isn't unusual, and the leakage can occur out-of-sight and mind. And complete failures can result in costly damage. It doesn't help that faucets have multiple points where failure may occur: fracture at the thread shank(s), fracture of the cartridge, improper connections and failure of the integral supply lines. That's why it's important to send the entire faucet for inspection -- a leak found in one area my originate somewhere else.

Harbor Freight Tools Recalls Cordless Drills Due to Fire and Burn Hazards

Recall date: December 1, 2015

Name of product: Drill Master 18-Volt Cordless Drills

<u>Hazard:</u> An internal switching mechanism can become stuck in the "on" position and overheat, posing fire and burn hazards.

Units: About 1.7 million units

<u>Description:</u> This recall involves Drill Master 18-volt cordless drills with item number 68239 and item number 68287. The drills are black with a red switch and were sold with an 18 volt rechargeable battery pack. Item number 68239 was sold individually and item number 68287 was sold as part of a kit, which included a flashlight. The flashlight is not included in the recall. The item number is located on a

black label on the right side of the drill, just beneath the serial number. Drills with item number 69651 and item number 69652 are not included in the recall.

<u>Incidents/Injuries:</u> Harbor Freight Tools has received 25 reports of the drill switch overheating, including six reports of burns to the hands and fingers, and five reports of minor property damage.

<u>Remedy:</u> Consumers should immediately stop using the recalled drills and return the unit to the nearest Harbor Freight Tools store to receive a replacement drill.
