Trending Now at DPI



Over the past two years, DPI has received multiple **Price Pfister dual-handle faucet assemblies** (left) for inspection.

The faucet styles vary, but the failed faucets all feature black plastic coupling nuts (top right) that attach to threaded brass adapters (middle right).

Installation failure occurs most frequently due to overtightening of the thin-walled plastic nut with a tool and/or the use of thread paste, which can act as a lubricant and can also lead to overtightening (bottom right). The installation instructions for these faucet nuts clearly state: "Hand Tighten".

Name of product: Ventilation Fans

Hazard: The fan motor can overheat, posing a fire hazard.

Units: About 450 in U.S. (in addition, 200 were sold in Canada)
