### **Recall Alert**

As of September 2019, over 20,368,538 units of products sold were listed on the Consumer Product Safety Commission's Recall List. Following is a small sampling of those recalls.

Apple AC World Travel Adapter Kits; The three-prong AC wall plug adapters can break and expose the metal portion of the adapter, posing an electric shock risk. <u>Recall details</u>

H.E. Industrial Recalls Electric Garage Heaters; The heating element can overheat, posing a fire hazard. <u>Recall details</u>

Bodum Bistro Toasters; The recalled toasters can leak electric current when operating at the maximum normal temperature, posing a shock hazard to consumers. <u>Recall details</u>

AmazonBasics 1500 Watt Ceramic Space Heaters; The heater can overheat, posing fire and burn hazards. <u>Recall details</u>

Hunter Brunswick three and four light ceiling fans; The light kit wires can be damaged, posing an electric shock hazard to the consumer. <u>Recall details</u>

ASKO dishwashers; The dishwasher power cord can overheat, posing a fire hazard. Recall details

VIQUA Solenoid Valve Kits; Electrical current could leak from the solenoid valve, posing an electrical shock hazard to the user. <u>Recall details</u>

Carrier- and Bryant-branded 1.5-ton multi-zone, 4-ton multi zone and 4-ton single-zone ductless heat pumps; The fan motor on the heat pumps can fail, causing the units to overheat, posing a fire hazard. Recall details
