



Trending Now at DPI

Household single-handle valves are usually installed in-line with plumbing and are thus situated behind walls, under floors and so on. And even though they are designed to control water flow, such valves are typically installed and remain in an open position. Traditionally, these valves were made of sturdy materials and offered long-term performance.

Since the introduction of "no lead" laws across the country, DPI has seen an increase in the amount of failed single-handle valves. Either due to changes in design, the use of lower quality materials, or both of these factors, some valves seem to have less reliability than before. Recently, DPI has received more of these valves where sections have completely fractured and separated, and the brass material has deteriorated (left photo) after a short time in service. Also, some of these valves suffer multiple small cracks at one port or another (right photo). Click here for more detailed information.

Academy Sports + Outdoors Recalls Turkey Fryer Due to Fire Hazard This recall involves the Academy Sports + Outdoors Outdoor Gourmet Turkey Keg which is a turkey fryer made of stainless steel and powered by propane. The fryer, including the legs, measures 34 inches high by 17 inches wide. The item number is 157826 and is located on a label on one of the four legs.

Consumers should immediately stop using the recalled Outdoor Gourmet Turkey Keg and return it to any Academy Sports + Outdoors store for a full refund and a \$50 Academy gift card.
